Archaeology and Landscape History

Undergraduate Certificate in Archaeology of Ancient Britain

This course will give you a solid introduction to the practice, methods, theories and key sources used by archaeologists. It is open to everyone regardless of previous educational experience. The course will introduce you to the Neolithic, Bronze and Iron Ages and then focus on Romano-British society from the Roman Conquest to the settlement of the Saxons.

Please note that this is one of two Archaeology Certificate courses, which typically run in alternate years. They can be studied independently of each other, and in any order. The second course is the *Undergraduate Certificate in* Archaeology of the Ancient World (previously Certificate II).

Undergraduate Certificate in the Making of the English Landscape: Landscape History and Archaeology

This course takes as its starting point W G Hoskins' ground-breaking Making of the English

Landscape (1955). Each unit explores how our understanding of the history of the English landscape has changed since the mid-1950s, and demonstrates how the modern landscape. together with documentary archaeological, architectural and ecological evidence, can be used to unravel long-term continuities and changes in the evolution of the rural landscape from prehistory into the 19th century. The course aims, too, to support anyone who wishes to explore their own landscapes of interest

Please note that this is one of three English Landscape courses, which typically run in alternate years. They can be studied independently of each other, and in any order. The other courses are the *Undergraduate Certificate in the* Making of the English Landscape: Garden History (previously Certificate II) and the Undergraduate Certificate in the Making of the English Landscape: Sources and Methods (previously Certificate III).

Medieval documents, buildings and artefacts survive in archives, landscapes and galleries, sometimes in remarkable numbers and in a remarkable state of preservation. This course will help you to develop an interdisciplinary overview that uses this range of material to address large questions: the complexity of changing power relationships between lords, gentry and peasants; the influence of dramatic climate change and deadly epidemics on social and economic structures; agricultural conservatism and innovation in attempts to

meet these challenges; and the importance of changes in ideas expressed in art and religion in cultural transformation.

Please note that this is one of two linked Certificate courses, which typically run in alternate years. They can be studied independently of each other, and in any order. The second course is the *Undergraduate Certificate in the Study of Early Medieval England*.

Undergraduate Diploma in Archaeology: Death and the Ancient World *

This course will give you an advanced and in-depth knowledge of a key prehistoric and historic period in the archaeology of the ancient world. This is coupled with an insight into the study of bones and ancient diseases, so vital in the interpretation of prehistoric and historic periods. The course is open to all regardless of previous educational experience, although prior study at Certificate level is recommended.

Please note that this is one of three Archaeology Diploma courses, which typically run in alternate years. They can be studied independently of each other, and in any order. The other courses are *Undergraduate Diploma in Archaeology:* Conflict, History and Heritage (title subject to approval; previously Diploma II) and *Undergraduate Diploma in Archaeology: Methods and Practice* (title subject to approval; previously Diploma III).



Architecture and Design

Undergraduate Certificate of Higher Education in Historic Building Conservation

This course runs every two years, and will be offered next in 2019.

This two-year course offers an introduction to the philosophy and practice of historic building conservation, with an emphasis on developing an understanding of the traditional crafts involved. It is taught by means of lectures, visits and field trips across East Anglia to view buildings and practitioners at work. Classes take place at ICE's headquarters, Madingley Hall, a 16th-century manor house set in eight acres of landscaped gardens designed by Capability Brown.

This course is for graduates who have obtained RIBA/ARB Parts 1 and 2 or have confirmation of Parts 1 and 2 equivalence from the Architects' Registration Board (ARB). Successful completion of the course qualifies you to register with the ARB and thereafter be called an architect. It also entitles you to take up corporate membership of the Royal Institute of British Architects (RIBA). Thereby, it is the formal entry into the profession. The course acts as a forum for discussion of certain major concerns of the profession as well as providing preparation for the examination.



MSt in Building History

This academically rigorous yet practical course aims to equip you for careers in historic building investigation, research, recording, assessment, management and interpretation. The course, delivered by the Department of Architecture and devised in collaboration with English Heritage (now Historic England), is unique in combining British architectural history with practical tuition in interpreting building fabric.

MSt in Construction Engineering

The aim of this course is to develop and empower emerging leaders to transform the construction industry. It is an advanced leadership programme aimed at future leaders of the industry. The course is offered by the Department of Engineering in association with the Cambridge Judge Business School at the University of Cambridge.

MSt in Interdisciplinary Design for the Built Environment

This transformative course is designed for global practitioners working in the built environment. Intensive, themed residential weeks deliver a bespoke learning experience, which develops individual and professional skills in multidisciplinary teamwork, the design process and individual research. The course is delivered by the Cambridge Institute for Sustainability Leadership in association with the Departments of Architecture and Engineering.


